

NOTICE OF LIQUIDATION – Dates of notice 23 August 2005 and 31 August 2005

Pursuant to Section 39.6 of UNMIK Regulation 2001/6, NOTICE IS HEREBY GIVEN that the Liquidation of the enterprises below was commenced with effect from 1 August 2005 pursuant to a decision of the Board of the Kosovo Trust Agency dated 21 July 2005 under Section 9.1 of UNMIK Regulation 2002/12 on the Establishment of the Kosovo Trust Agency, as amended by Regulation 2005/18.

Filing Claims

Any person who believes he/she has a claim against the Enterprise– either as creditor or in respect of any assets related to it or as an owner of the Enterprise or any other claim - should file a Liquidation Claim as soon as possible at the points below.
